Additionally, you are required to pass online course called Professional Ethics Module and to prove completion of three years' relevant practical experience PER and achieve 13 performance objectives.

Business Law (K3) has been moved from the former Applied Skills level to Knowledge level, while Business and Technology has been removed from Applied Knowledge level completely. In addition, new essential employability modules have been introduced at the Knowledge and Expertise levels.

The Strategic Professional Exams structure has been redesigned. The previous Essentials paper Strategic Business Reporting (SBR) has been replaced. Under the new structure, Business and Sustainability Reporting becomes a core requirement together with Strategic Business Leader.

The Options section has also changed significantly. Instead of choosing 2 out of 4 technical exams, candidates now choose 1 out of 5 professional pathways.

When it comes to PER, the required duration remains 36 months, but ACCA now allows candidates to count up to 6 months through Simulated Experiential Learning.
